REQUEST FOR QUOTE (RFQ)

I. PURPOSE:

The District is seeking a qualified, licensed and insured contractor to concrete existing gravel driveway and parking lot at Station 2 as identified in the Scope of Work. The remainder of this document provides additional information that will allow a bidder to understand the scope of effort and develop a quote.

II. SCOPE OF WORK

A. Excavate:

- a. Grade and compact area for proper drainage. Move railroad ties and place them in a designated area on the north side of Station 2 lot. Replace drainage pipe at the driveway entrance (177th E Ave).

B. Concrete Work

- a. Supply and forms to Grade. Supply, pour and finish 6" of ODOT Class A 3500 psi. paving concrete with ODOT approved rock and Fibermesh. Saw cut with a Soffcut saw per ACI standards and apply an ODOT approved cure and seal.
- b. Supply, pour and finish Pin on Curbs and Returns.
- c. Tie-in with 177th East Ave and Oklahoma State Highway 20 shall comply with all State and County requirements.

C. Clean up site

III. SERVICE, SERVICE AND ANNUAL MAINTENANCE

- A. Bidders will include warranty information on all repairs and services, including the length of the warranty.

IV. BIDDER RESPONSIBILITY

- A. The bidder is responsible for supplying their own tools, equipment, materials, and supplies.
- B. The bidder is responsible for supplying a current Certificate of Workers' Compensation prior to work commencing.
- C. The bidder is responsible for supplying Plans to the District and to Rogers County for purposes of obtaining all required permits
- D. The bidder is responsible for obtaining all required permits.
- E. The bidder is responsible for contacting Call OKIE and appropriate utilities for detection of any sub-surface hazards.
- F. The bidder is responsible for clean up of the site after work has been completed.
